

Information on processing of personal data pursuant to art. 13-14 Reg.to EU 2016/679

Parties concerned: **Customers, suppliers and insurance companies**

D.E.I. S.R.L. as Data Controller of your personal data, pursuant to and for the effects of EU Reg. 2016/679 hereafter referred to as 'GDPR', hereby informs you that the aforementioned law provides for the protection of data subjects regarding the processing of data personal data and that this treatment will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Your personal data will be treated in accordance with the aforementioned law and the privacy obligations therein.

Purpose of processing: in particular, your data will be processed for the following purposes related to the implementation of legal obligations or contractual requirements:

- Obligations required by law for tax and accounting purposes

Moreover, the Data Controller hereby states that failing to provide any of the compulsory information or providing incorrect information may make it impossible for the Data Controller to guarantee that the data itself is processed appropriately.

Processing methods: your personal data may be processed in the following ways:

- Treatment of electronic archives
- Manual processing using hard-copy archives

Each treatment is carried out in accordance with the procedures laid down in Articles. 6, 32 of the GDPR and through the adoption of appropriate security measures provided.

Communication: your data will be communicated exclusively to competent subjects and duly appointed for the performance of services which are necessary for the proper management of the relationship, with a guarantee of protection of the rights of the person concerned.

Your data will be processed only by expressly authorized by the Data Controller and, in particular, by the following categories of employees:

- Administrative Office
- Administration and accounting
- Commercial
- Logistics - Warehouse
- Quality

Your data may be disclosed to third parties duly appointed Officers to treatment, instructed to perform specific services relating to the obligations under the above mentioned aims in particular to:

- Banks and Credit institutions
- Shippers, carriers, owner-operators, logistics companies
- Consultants and freelancers, also in associated form

Disclosure: Your personal data will not be disclosed in any way.


